REPORTS:

- A. **CAC "Meeting Challenges" Calendar for 2021 Topic** Jessica Ceja, Parent School Liaison led the CAC members in a brainstorming session for the 2021 CAC "Meeting Challenges" calendar.  - Music/Entertainment Discussion Several students with disabilities joined the summer youth music and leadership program sponsored by the League of United Latin American Citizens and experienced wonderful successful. The CAC agreed to ask them to perform.
- C. A review of all Parent Workshops for Spring 2020 was provided by Norma Erwin.

NEW BUSINESS:

A. "Behavior Strategies in the Classroom" - Rashella Avalos-Senteno, Director of Special Education presented an overview of behavioral strategies frequently used in the classroom and school site such as research and evidence based practices, classroom management systems, Trauma Informed Practices, alternative means of correction and promoting positive school culture. Rashella provided an explanation of Multi-Tiered Support System, Positive Behavioral Intervention Support, SUMS Initiative and Response to Intervention. There are also behavioral strategies that are typically implemented throughout the school district for all students. For example, Positive Behavior Reward Systems and visual supports are posted in the classrooms, cafeteria, library and other areas within school campus, and provide clear behavioral expectations district wide.
